## **SECTION 4: FIRST AID MEASURES**

SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS:

#### **SECTION 7: HANDLING AND STORAGE**

Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where material is handled, stored and processed.
